### 1.0 CALL MEETING TO ORDER

President Vaughan called the meeting to order at 6:04 p.m.

### 2.0 PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE

### 3.0 ROLL CALL

The following members of the Board of Trustees were present: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins. A quorum was present. Also present: Executive Director Jim Pilmer, Attorney Gerald Hodge, administrative staff and guests.

### **4.0 ADDENDA TO THE AGENDA** – None presented.

### 5.0 CONSENT AGENDA

Rachel Ossyra motioned, Alex Alexandrou seconded and the board unanimously approved the consent agenda items. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

### 6.0 PRESENTATIONS AND SPECIAL RECOGNITION

#### 6.1 Jordan Real induction into the West Aurora High School Athletic Hall of Fame.

Bob Vaughan recognized Jordan Real for her recent induction into the West Aurora High School Athletic Hall of Fame. He congratulated her on her athletic accomplishments and contributions to West Aurora High School's volleyball and basketball teams.

### 8.0 ATTORNEY BUSINESS

8.1 Semi-Annual Review of Closed Session Minutes: Approve a Resolution for the (1) release of certain closed session minutes in full relating to the period July 2015 – December 2015 and (2) continued redaction of certain closed session minutes in whole or in part and (3) destruction of certain closed session verbatim recordings made prior to July 2014.

Attorney Hodge advised the board that every six months there is a review of closed session minutes to authorize the release of those minutes that contain transactions that are completed and matters that are concluded. Any minutes containing matters that continue to be pending stay redacted. He reviewed all minutes to determine which portions can be released and which need continued redaction. Alex Alexandrou motioned, Cynthia Penne seconded and the board unanimously approved a Resolution for the (1) release of certain closed session minutes in full relating to the period July 2015 – December 2015 and (2) continued redaction of certain closed session minutes in whole or in part and (3) destruction of certain closed session verbatim recordings made prior to July 2014. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

### 9.0 EXECUTIVE DIRECTOR BUSINESS

### 9.1 IAPD/IPRA Conference

Executive Director Jim Pilmer reported 16 staff participated in the conference which was held January 28-30 in Chicago. Staff attended a team building social on Thursday evening. A highlight of the event was the awards luncheon held on Friday, January 29; three legislators attended as guests at the Fox Valley Park District table: Rep. Kifowit, Rep. Chapa LaVia, and Sen. Oberweis. The park district also provided transportation to and from the luncheon, of which Sen. Holmes participated. Jim recognized Ray Nugent for providing the transportation. He reported that Carolyn Nagle of the Fox Valley Special Recreation Association received the IPRA Robert Artz Lifetime Achievement Award; to qualify you must have 25 years of service to the park and recreation association, of which at least 15 of those must be in Illinois. To follow the conference, staff will each present one 5-minute overview of a session to share, similar to a TED Talk. Jon Michael will post each presentation to the district intranet. He thanked the board for the opportunity to attend the conference.

### 9.2 Executive Director's Report

Jim reported that on January 12, he met with City of Aurora Mayor Weisner along with Bob Vaughan, Jeff Palmquist and Carie Anne Ergo to begin discussions on the mutual land acquisition opportunities for each entity. The City of Aurora is currently meeting with their development staff; Jim expects to report on that to the board sometime in March.

Jim reported that he and Cathy Schwieger met with the Visiting Nurses Association of Fox Valley. As of 2014, they are the third largest federally funded health care center in Illinois; they serve over 65,000 individuals per year. He is in the early stages of discussing and exploring an opportunity of a health and wellness partnership with them.

He highlighted the Digital Footprint from the marketing department illustrating the impact that the district is making on social media; the RecTrac training is the district's new software program scheduled to "go live" May 1; March 26 the district will be hosting a job fair.

Jim told the board that typically, officers of the board are elected every January. He advised the board that after consulting with Attorney Hodge, he is requesting that the board officers stay in succession until May, at which time the election of officers will be held. The reasoning is that there will be board elections in April 2017, with new officers being elected in May 2017.

### **10.0 CONTINUED BUSINESS** – None presented.

### 11.0 NEW BUSINESS

### 11.1 Appointments to Aquatics Administrative Board (2-year term for board members; 1-year term for community at large.)

Rachel Ossyra asked if she and Chuck Anderson could still serve on the Aquatics board even if they are no longer active Board of Trustee members after the April 2017 elections. Attorney Hodge responded that his recollection of the aquatics agreement is that it contains standard language stating board members shall serve until the successors are duly appointed and qualified and active. Alex Alexandrou asked the same and if it would be legal and binding, and Attorney Hodge added that if the newly elected board in 2017 wants to change these appointments before December 31, 2017, they would have every right to do that. Jim added that these dates were intentionally chosen to add stability to the aquatic season for 2017.

Theodia Gillespie motioned, Denny Wiggins seconded and the board unanimously approved for the 2016-17 service years, the following two Fox Valley Park District Board member appointments to the Aquatic Administrative Board, and for the 2016 service year approved the following one appointment to the Aquatic Administrative Board from the community at large:

1) Board member Chuck Anderson for a 2-year term to expire December 31, 2017

2) Board member Rachel Ossyra for a 2-year term to expire December 31, 2017

3) Paul Greviskes from the community at large for a 1-year term to expire December 31, 2016

Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

# **11.2** Approve the proposed family pass type and fees for the outdoor aquatic facilities to be implemented in the 2016 operating season.

Jaime Ijams reported to the board that in a targeted effort to respond to the community's recommendations for a family discount option at the outdoor aquatic centers and to help increase the guaranteed source of revenue for the season passes, the district is seeking approval to implement a family pass at the outdoor aquatics centers. Staff have evaluated the feasibility of offering a family season pass option and researched pricing of several surrounding park districts, of which the majority, if not all, offer a family season pass. Fox Valley Park District typically sells about 76 percent of season passes between March and May using the early bird discount rate. Jaime said she is proposing a family pass for a family of four or more which would offer an additional 8 percent off the early bird rates. This is one way to increase season pass revenue. Bob Vaughan asked if the definition of family would include having the same residence. Jaime said yes, it would be two adults 21 and over living in the same household. Bob asked if we know how many households the district has with four members or more. Jaime said we don't know that number right now but she has figured if the district were to lose some of the adults, how that would affect us, and how many new families the district would want to bring in to offset the price.

Theodia Gillespie motioned, Cynthia Penne seconded and the board unanimously approved the proposed family pass type and fees for the outdoor aquatic facilities to be implemented in the 2016 operating season. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

# **11.3** Approve the bid submitted by Cipher Limited, Aurora, Illinois, for the fabrication and installation of four scoreboards at the Stuart Sports Complex in the amount of \$44,800.

Jeff Palmquist told the board that since the opening of Stuart Sports Complex the district has continued to add amenities and upgrades to make the complex as desirable as possible to be a destination for tournaments. As part of this initiative, the district purchased four scoreboards last year. Two sign companies responded to the RFP with Cipher Limited being the low bid. Jeff said they are very qualified. Alex Alexandrou asked if the new scoreboards are wireless; Jeff said yes, and the district worked on a protocol for the wireless.

Denny Wiggins motioned, Alex Alexandrou seconded and the board unanimously approved the bid submitted by Cipher Limited, Aurora, Illinois, for the fabrication and installation of four scoreboards at the Stuart Sports Complex in the amount of \$44,800. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

# **11.4** Approve the bid submitted by The Kenneth Company for the construction of the Cumberland Park playground improvements in the amount of \$196,751.

Jeff Palmquist said the concept plan for the Cumberland Park renovations was approved by the board in September 2015 with the understanding that the funding for the construction would be provided in FY2016. The district received a very competitive group of bidders, with the Kenneth Company being the lowest responsive, responsible bid. There was one bid lower by Elanar but they formally withdrew their bid when they realized they omitted a key line item cost. The bid by Kenneth is still \$30,000 under the district's estimate. Kenneth Company has done work for the district in the past and references were checked which were very strong.

Chuck Anderson motioned, Cynthia Penne seconded and the board unanimously approved the bid submitted by the Kenneth Company for the construction of the Cumberland Park playground improvements in the amount of \$196,751. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

### 11.5 Approve the Washington Park playground renovation concept plan.

Jeff Palmquist presented a concept plan to the board for renovations of the Washington Park playground which is 18 years old. The district has received a number of service calls and the park is high on the list for renovations. The plan calls for newer and more diverse equipment, as well as a small shade shelter.

Chuck Anderson motioned, Rachel Ossyra seconded and the board unanimously approved the Washington Park playground renovation concept plan. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

# 11.6 Approve Door-to-Door Direct as the activity guide delivery service for the Summer, Fall and Winter 2016 books, in an amount not to exceed \$32,400.

Dan Leahy informed the board that the printing of the books is done by RR Donnelley; this item concerns the delivery of the book. For a number of years the district has delivered the books through Door-to-Door Direct. He said they are one of the few companies that can meet the saturation mailing of 72,000 households in the district. Chicagoland Circulation Services is a comparable company but the cost is about 20 percent more than Door-to-Door Direct. The U.S. Post Office would be about a 200 percent price increase.

Denny Wiggins motioned, Chuck Anderson seconded. Alex Alexandrou asked how much the delivery cost was in the past. Dan said it's been \$10,800 for the past two years. The board unanimously approved Door-to-Door Direct as the activity guide delivery service for the Summer, Fall and Winter 2016 books, in an amount not to exceed \$32,400. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

### 12.0 CLOSED SESSION

Alex Alexandrou motioned, Theodia Gillespie seconded and the board unanimously approved concluding the open session at 6:35 p.m. and moving into closed session for the reasons stated on the agenda. Roll call – voting Aye: Alex Alexandrou, Chuck Anderson, Theodia Gillespie, Rachel Ossyra, Cynthia Penne, Bob Vaughan and Denny Wiggins; voting Nay: none. Motion carried.

Denny Wiggins motioned, Alex Alexandrou seconded and the board unanimously approved by voice vote to return to open session at 7:52 p.m.

# Fox Valley Park District Financial Statement Summary Narrative January 2016

#### Fund 100 - Corporate Fund

For the month of January, the Corporate Fund received \$85,885 in Replacement Taxes, \$7,252 in Rental Income, \$6,895 in investment income. Expenses for the month include \$6,944 for NRPA membership fees, \$22,879 for natural area contract and \$8,392 for maintenance to small equipment. Year-to-date non-tax revenues are 11.5% unfavorable to last year at this time and expenses are 14% unfavorable to last year at this time.

#### Fund 101 - Liability Fund

During January, the Liability Fund received \$1,500 from PDRMA for loss control incentives. Expenses for the month include \$1,958 for safety supplies.

#### Fund 105 - Orchard Valley Golf Course

Since 2010, the Billy Casper Golf Management Company (BCG) took over the management of the Orchard Valley Golf Course and Restaurant. We will not be recording their monthly financial information on our computer system, except for the capital improvements and licenses agreement fees and other revenues as outlined in the agreement. Expenses for the month include \$38,779 for the remaining payments on the bunker repairs.

#### Fund 107 - Aquatics

The outdoor pools have been closed for the season since September. No significant revenues are received until we open in June. The only major expense for January includes \$3,245 for HVAC repairs at Splash Country, \$4,574 for repairs to the boiler and \$3,239 for electrical repairs at Splash Country.

## Fund 108 - 2008A Referendum G.O. Bonds

This fund tracks capital projects that are funded from our 2008 Referendum. For the month of January no significant revenues or expenditures were recorded.

#### Fund 109 – Fox Bend Golf Course Proceeds

During the month of January this fund received \$1,680 in investment income. No expenses were recorded for the month. The April 30, 2015 fund balance is \$1,116,764. Based on January year-to-date financial activity, the available balance for future projects is \$1,124,038.

#### Fund 200 - Recreation Fund

For the month of January, the Recreation Fund had Fees and Memberships of \$358,851 and Program Revenues of \$335,773. Last January, revenues for these categories were \$363,804 and \$369,539, respectively. Other January revenues include \$70,557 in Rental Income, \$6,789 in VAC Café sales, \$3,023 in Tennis Pro Shop Sales and \$13,919 in investment income. Expenses during January include \$25,583 for electric at the VAC and \$5,182 at Eola, \$11,236 for natural gas at the VAC, \$5,833 for Jeff Ellis Management services, \$6,330 for custodial services at Prisco, \$8,753 at Eola and \$6,169 for the VAC, \$8,621 for building repairs at Prisco and \$12,850 at the VAC, \$9,824 for credit card and bank fees and \$31,000 for Jeff Ellis contracted labor, \$6,902 for turf contracts at Stuart Sports Complex, \$29,210 for fitness equipment at Eola and \$93,777 for fitness equipment at the VAC. Year-to-date non-tax revenues are 2.6% unfavorable compared to last year at this time and expenses are 8.8% favorable to last year at this time.

# Fund 201 - Museum Fund

For the month of January, revenues for this fund included \$781 in investment income, \$12,591in revenue from the Holiday Express at Blackberry Farm. Expenses for the month of January include \$13,891 for a new septic system at Red Oak Nature Center. Year-to-date non-tax revenues are 15.2% favorable to last year at this time and expenses are 6.1% favorable to last year at this time.

# Fund 202 - Police and Security Fund

For the month of January, expenses for the month include \$1,488 for utilities, \$1,200 for software renewal and \$1,223 in materials and supplies. Year-to-date non-tax revenues are 16.8% unfavorable to last year at this time and expenses are slightly favorable to last year at this time.

## Fund 203 – Communities in Schools

This fund is used as a pass through account for grant distribution for Communities in Schools.

## Fund 205 - Fox Valley Special Recreation

For the month of January, expenses for this fund included \$5,234 for inclusion fees.

# Fund 206 - Illinois Municipal Retirement Fund

For the month of January, expenses include IMRF costs for payroll of \$54,142 which is net of the contributions from the aquatic centers to cover their portion of IMRF expense.

## Fund 207 - Social Security Fund

For the month of January, expenses include FICA costs for payroll of \$40,083 which is net of the contributions from the aquatic centers to cover their portion of IMRF expense.

## Fund 208 - Audit Fund

For the month of January no significant revenues or expenses were recorded for this month.

## Fund 209 – Facility Improvement/Replacement Fund

This fund was created to set aside funding for future capital improvements, renovations and replacement of the District's recreation facilities and operations. For the month of January, this fund received \$2,174 in investment income. Expenses include \$6,565 for building upgrades at Eola.

Fund 301 - Land Cash Fund

During the month of January no significant activity was recorded.

# Fund 304 - Equipment & Vehicle Replacement

This fund has been created to use in the future as a source of funding for the replacement of vehicles and equipment. The source of revenues for this fund comes from the sale of surplus

fixed assets and Transfers In from operating funds that use vehicles and equipment to be purchased from this fund in the future. For the month of January this fund received \$656 in investment income. Expenses include \$5,270 for two truck plows.

## Fund 305 - Land Acquisition Fund

This fund has been created to use in the future as a source of funding for acquiring land. The source of revenues from this fund comes from fees received for easements. Any land acquisitions for this year are budgeted in the 2008 Referendum Fund. During the month of January no significant activity was recorded.

## Fund 309 - 2010 G.O. Bonds

This fund tracks the bond proceeds from the January 2009 Build America Bond issue and the associated capital projects this issuance funds. During the month of January no significant activity was recorded.

# Fund 400 - Debt Service Fund

This fund records all debt payments of the park district. For the month of January, revenues for this fund include \$28,235 in Property Taxes and \$27,225 in Build American Bond Rebate. Included in the January financial reporting is the Refunding of the 2009A bond.

# Funds 600 - Employee Benefit Fund

The Employee Benefit Fund is the fund where all activity for the district's partially self-funded health plan is recorded for active employees. The fund balance ending December 31, 2015 is (\$216,192) which indicates a deficit fund balance. For this year to date period, this fund has revenues in excess of expenses of \$31,929.

## Funds 601 – Other Post Employment Benefit Fund (OPEB)

The OPEB Fund is the fund where all activity for the district's partially self-funded health plan is recorded for retirees. The fund balance ending December 31, 2015 is \$769,758. For this year to date period, this fund has revenues in excess of expenses of \$205,684 which includes a transfer in from other funds.

#### **Strategic Plan Objectives:**

• Evaluate need for expanded garage and storage space at the Park District Police and Public Safety facility, and determine source of funding. <u>Status</u>: Completed – It was determined that in order to better preserve our police fleet, added space is necessary. Currently we have garage space for six vehicles and there are an additional six parked outside year-round. There is adequate space for a structure on District owned property directly south of the police office.

Funding will be addressed in the 2016-2017 police budget.

Develop a recruitment plan to ensure that, due to attrition, open law enforcement positions are promptly filled.
 <u>Status</u>: Ongoing – Staff has experienced an extremely high rate of attrition during the past few months. The vacancies are primarily due to staff relocating out of the area. These vacancies are going unfilled. We are constantly advertising for applicants and receiving applications, but the overwhelming majority do not meet minimum qualifications for the position.

Research shows that we are losing qualified candidates to other area departments primarily due to our entry level rate of pay. The rate is approximately 30 percent less than other area departments.

A comprehensive review of our recruitment effort will be addressed in the 2016-2017 budget.

- Prepare for CALEA reaccreditation. <u>Completed</u> – The onsite evaluation was held November 30 – December 2 and it appears everything was in order and we will receive a favorable recommendation.
- Evaluate squad car video software and implement technology that downloads images efficiently.
   <u>Status</u>: Completed With the upgraded software, the squad car cameras are being downloaded automatically when the squads return to the garage at the completion of each shift. The images are stored on a dedicated computer in the police office for later review or as evidence.
- Provide training for the enhanced law enforcement records management system.
   <u>Status</u>: Completed.
- Provide NIMIS 200 training for all emergency responders.
   <u>Status</u>: Completed Many of our officers have gone on to 300 and 400 level training.
- Develop an intergovernmental emergency response plan for Stuart Sports Complex.
   <u>Status</u>: Completed – A meeting was held at the Complex on July 1.
   Representatives of all the responsible jurisdictions were in attendance and we feel very comfortable that we have in place a very comprehensive plan.

   <u>Status</u>: Completed A PSO was added to assist our officers in visiting the playgrounds. On June 25 a picnic was held at McCullough Park. Approximately 250 children were in attendance. Also in attendance were representatives from five other law enforcement or fire agencies that brought equipment for the program participants to view and interact with.



At the October 19, 2015, meeting of the Fox Valley Park District Board of Trustees, the Board approved the license agreement between the Fox Valley Park District and the City of Aurora regarding the expansion of the Animal Control and Care Facility parking lot. This agreement allows the City to expand the Animal Control parking lot onto adjacent Park District property by 20 feet (see attached agreement and exhibit). By utilizing the 20' deep License Agreement Area that lies across the northern edge of District property, the Animal Control facility can efficiently construct head-in parking stalls along the south side of its existing parking lot drive and gain as many as 20 parking spaces with minimal impact to Park District property. In exchange for this minor encroachment across District property, the City has agreed to allow park patrons access to this parking lot.

The term of the agreement, as approved by the Fox Valley Park District Board of Trustees, is ten years (with renewal periods to be determined by mutual agreement). However, as the City administration has completed its review of the agreement, the City is asking for the initial term be lengthened to twenty years instead of ten years. Park District staff has no issues with this revision.

I recommend to the Board of Trustees to approve the revised agreement between the Fox Valley Park District and the City of Aurora for Animal Control and Care Facility parking lot expansion.

The current Fund Balance Policy was approved by the Board in 2012. This policy served as good general informational document for the District. The current best practice of the Governmental Finance Officers Association (GFOA) and Fred Lantz at Sikich recommends targeting unassigned fund balances in the General and Recreation Funds.

The recommendation includes targeting the unassigned fund at no less than three months or 25% and no more than six months or 50% unless approved by the Board of Trustee, Executive Director and or Chief Fiscal Officer. In addition, the Illinois Compiled Statutes (70 ILCSA 1205/5-1) allows for any excess funds not pledged or allocated for a specific purpose to be transferred into a Capital Development Fund. This Capital Development Fund can accumulate these excess funds for future capital needs for Board of Trustee approval.

By isolating the capital expenditures to primarily one fund, budgeting and tracking of these projects will become more evident. It will also aid in the isolation of the operating expenditures for our Corporate and Recreation Funds. By creating the Capital Fund it will eliminate two of our funds which were intended for capital projects but do not meet the same transparency, requirements and compliance that this new fund would provide.

I recommend to the Board of Trustees approval of the Fund Balance Policy.

# **Fund Balance Policy**

## A. Statement of Purpose

The purpose of this policy is to establish fund balance classifications, principles and parameters that establish fund balance targets which will be defined at the beginning of each budget period. This policy is to provide a process by which we obtain financial stability, cash flow for operations, and the assurance that the District will be able to respond to emergencies with fiscal strength and sustainability. It is anticipated that unexpected situations may cause the Park District to fall below the minimum level, at which point certain steps will be followed to correct the deficiency.

The fund balance will be composed of three primary categories:

- 1) Nonspendable Fund Balance
- 2) Restricted Fund Balance
- 3) Unrestricted Fund Balance
  - Committed
  - Assigned
  - Unassigned

## **B.** Definitions

**Governmental Funds** - are used to account for all or most of the District's general activities, including the collection and disbursement of restricted or committed monies (special revenue funds), the funds restricted, committed, or assigned for the acquisition or construction of capital assets (capital projects funds) and the funds restricted, committed, or assigned for the servicing of long-term debt (debt service funds). The general (corporate) fund is used to account for all activities of the District not accounted for in some other fund.

*Fund Balance* – the difference between assets and liabilities in a Governmental Fund.

**Nonspendable Fund Balance** – the portion of a Governmental Fund's fund balance that is not available to be spent, either short-term or long-term, in either form or through legal restrictions (e.g., inventories, prepaid items, long-term loans, endowments).

**Restricted Fund Balance** - the portion of a Governmental Fund's fund balance that is subject to external enforceable legal restrictions (e.g., creditors, grantors, contributors and property tax levies).

Unrestricted Fund Balance is made up of three components:

**Committed Fund Balance** - the portion of a Governmental Fund's fund balance where the constraint on spending the fund balance is self-imposed by formal action of the highest level of decision making authority (Board of Trustees).

**Assigned Fund Balance** - the portion of a Governmental Fund's fund balance constrained by the Park District's intent to use fund balance for a specific purpose.

**Unassigned Fund Balance** - available expendable financial resources in a governmental fund that are not the object of tentative management plans (i.e. assignments). Positive fund balance can only be recorded in the General Fund.

# C. Fund Balance Philosophy

It is the Park District's philosophy to support long-term financial strategies, where fiscal sustainability is its first priority, while also building funds for future growth. It is essential to maintain adequate levels of fund balance to mitigate current and future risks (e.g., revenue shortfalls and unanticipated expenditures) and to ensure stable tax rates. Fund balance levels are also a crucial consideration in long-term financial planning.

## D. Scope

This policy establishes the hierarchy of fund balance. Credit rating agencies carefully monitor levels of fund balance and unassigned fund balance in the Corporate (General) fund to evaluate the Park District's continued creditworthiness.

## E. Minimum Unrestricted Fund Balance Levels

This Policy applies to the Park District's governmental funds as follows:

**General Fund** - The General Fund is comprised of the Corporate Fund.- The Corporate Fund is used to account for most of the day-to day operations of the District which are generally financed from property taxes and other general revenues.

1.Each year a portion of the spendable fund balance will be determined as follows:

- a. Restricted A portion of the fund balance will be restricted based on the amount of unspent property tax revenue at fiscal year-end.
- b. Committed A portion of the fund balance may be committed through formal action of the Board of Trustees either through a resolution or ordinance.

- c. Assigned A portion of the fund balance may be assigned to the intended use of resources. The assigned fund balance may be established by the Board of Trustees and/or the Executive Director or Director of Finance.
- d. Unassigned The unassigned fund balance will be reviewed annually during the budget process. The General Fund unassigned targeted fund balance should represent no less than three months (25%) and no more than six months, or an estimated 50%, of annual budgeted expenditures unless approved by the Board of Trustees and/or Executive Director and/or the Chief Fiscal Officer (Director of Finance & Administration). Balances in excess of 50% of annual budgeted expenditures may be transferred to the Capital Projects Fund or the Recreation Fund, if needed. Park District Code (70 ILCS 1205/5-1) determines that "any funds on hand at the end of the fiscal year that are not pledged for or allocated to a particular purpose may, by action of the board of commissioners, be transferred to a capital improvement fund and accumulated therein, but the total amount accumulated in the fund may not exceed 1.5% of the aggregate assessed valuation of all taxable property in the park district." It may take more than one levy cycle to ensure that the fund is operating in the proper range.

**Special Revenue Funds** - Special revenue funds are used to account for and report the proceeds of specific revenue sources that are legally restricted or committed to expenditure for specified purposes other than debt service or capital projects. Financing for most special revenue funds is provided by a specific annual property tax levy. In some cases, financing is received from admissions, fees and charges for programs and activities. These proceeds are devoted exclusively to the purposes of which the special tax was authorized. Fund balances in special revenue funds (other than the Recreation Fund) are derived from property taxes and are therefore legally restricted to the purpose of the fund. Additionally, per state statute, Museum Fund program revenue is legally restricted to the purpose of the Museum Fund. The Liability Fund which provides for the district's overall risk management and tort judgments is considered to be included in this category of special revenue funds.

**Playground and Recreation Fund** – This fund is used to account for recreation, communication and marketing efforts for the District's general recreation programs and leisure experiences. Financing is provided from fees and charges for programs and activities and an annual property tax levy. Any accumulation of fund balance other than the deferred property tax is considered attributable to fees and charges. The target range is no less than three months (25%) and no more than six months (50%) of annual budgeted expenditures unless approved by the Board of Trustees and/or Executive Director and/or the Chief Fiscal Officer (Director of Finance & Administration). Park District Code (70 ILCS 1205/5-1) determines that "any funds on hand at the end of the fiscal year that are not pledged for or allocated to a particular purpose may, by action of the board of commissioners, be transferred to a capital improvement fund and accumulated therein, but the total amount accumulated in the fund may not exceed 1.5% of the aggregate assessed valuation of all taxable property in the park district."

within the target range. It may take more than one levy cycle to ensure that the fund is operating in the proper range. Balances above the maximum may be transferred to any other fund.

- 1. Each year a portion of the spendable fund balance will be determined as follows:
  - a. Restricted A portion of the fund balance may be restricted based on constraints imposed by creditors (use of bond proceeds, fund for repayment of bonds), grantors (use of grant funds), contributors (e.g., donors), or laws or regulations by other governments (e.g., compiled statutes).
  - b. Committed A portion of the fund balance may be committed through formal action of the Board of Trustees either through a resolution or ordinance and must be board adopted prior to the end of the fiscal year.
  - c. Assigned –A fund balance goal is annually adopted by the Board of Trustees in order to provide for financial stability. The remaining fund balance will be assigned to future operations and improvement for recreation programs

**Liability Fund** - The Liability Insurance Fund is a fund that accounts for the operation of the Park District's insurance and risk management activities. This fund records the insurance expenditures. Financing is provided from an annual property tax levy, the proceeds of which can only be used for this purpose. Fund balances in this fund are therefore legally restricted to the purpose of the fund.

1. The targeted restricted fund balance of the Liability Fund shall be calculated as follows:

- a. Restricted A portion of the fund balance may be derived from property taxes and therefore legally restricted to the purpose of the fund.
- b. Committed A portion of the fund balance may be committed through formal action of the Board of Trustees either through a resolution or ordinance and must be board adopted prior to the end of the fiscal year.
- c. Assigned –A fund balance goal is annually adopted by the Board of Trustees in order to provide for financial stability.

**Museum Fund** – This fund accounts for the activity of the Outdoor Education programs at the Red Oak Nature Center and Blackberry Farm facilities. Additionally, it is used to account for revenues derived from a specific annual property tax levy and expenses of these monies for the maintenance and operations of the Museum. Per state statute, Museum Fund program revenue is legally restricted to the purpose of the Museum Fund. 1. The targeted restricted fund balance of the Museum Fund shall be calculated as follows:

- a. Restricted A portion of the fund balance may be derived from property taxes and therefore legally restricted to the fund. A portion of fund balance may also be restricted based on constraints imposed by contributors (e.g., donors), or grantors (use of grant funds).
- b. The remaining restricted fund balance for this fund will be targeted at a minimum level that is annually adopted by the Board of Trustees in order to provide for financial stability.

**Fox Valley Special Recreation Association Fund** – The purpose of this fund is to supply the necessary resources to provide recreational programs for individuals with special needs and disabilities, and accounts for revenues derived from a specific annual property tax levy and expenditures of these monies.

1. The targeted restricted fund balance of the Fox Valley Special Recreation Association Fund shall be calculated as follows:

- a. Restricted A portion of the fund balance may be derived from property taxes and therefore legally restricted to the purpose of the fund.
- b. The remaining restricted fund balance for this fund will be targeted at a minimum level that is annually adopted by the Board of Trustees to provide for financial stability.

**IMRF Fund** – This fund accounts for the District's annual contributions to the qualified retirement plan for IMRF-designated employees. Revenues are provided by a specific annual property tax levy which produces a sufficient amount to pay the Park District's contributions to the fund on behalf of the Park District's employees. Fund balances in this fund are derived from property taxes and are therefore legally restricted to the purpose of the fund.

1. The targeted restricted fund balance of the IMRF Fund shall be calculated as follows:

a. Restricted – A portion of the fund balance may be derived from property taxes and therefore legally restricted to the purpose of the fund.

**Audit Fund** – The purpose of this fund is to provide financial resources to be used to prepare and publish the Comprehensive Annual Financial Report which is mandated by State statute. Financing is provided from an annual property tax levy, the proceeds of which can only be used for this purpose. Fund balances in this fund are derived from property taxes and are therefore legally restricted to the purpose of the fund.

1. The targeted restricted fund balance of the Audit Fund shall be calculated as follows:

- a. Restricted A portion of the fund balance may be derived from property taxes and therefore legally restricted to the purpose of the fund.
- b. The remaining restricted fund balance for this fund will be targeted at a minimum level that is annually adopted by the Board of Trustee in order to provide for financial stability.

**Park Police and Public Safety Fund** – This fund accounts for the funding and uses of resources for the District's public safety program to ensure guests have a safe and enjoyable environment while using District facilities, trails, parks and programs. Financing is provided from an annual property tax levy and are therefore legally restricted to the purpose of the fund.

1. The targeted restricted fund balance of the Park Police and Public Safety Fund shall be calculated as follows:

- a. Restricted A portion of the fund balance may be derived from property taxes and therefore legally restricted to the purpose of the fund. A portion of the fund balance may be also be restricted based on constraints imposed by grantors (use of grant funds), contributors (e.g., donors), or laws or regulations by other governments (e.g., compiled statutes).
- b. The remaining restricted fund balance for this fund will be targeted at a minimum level that is annually adopted by the Board of Trustees to provide for financial stability.

**Federal Insurance Compensation Act (FICA) Fund** – This fund accounts for the District's contributions for Social Security and Medicare for all employees. Financing is provided from an annual property tax levy and are therefore legally restricted to the purpose of the fund.

1. The targeted restricted fund balance of the Federal Insurance Compensation Act (FICA) Fund shall be calculated as follows:

- a. Restricted A portion of the fund balance may be derived from property taxes and therefore legally restricted to the purpose of the fund.
- b. The remaining restricted fund balance for this fund will be targeted at a minimum level that is annually adopted by the Board of Trustees in order to provide for financial stability.

**Family Aquatics Fund** – The District and The City of Aurora jointly operate two outdoor aquatic facilities and this fund accounts for the financial activity of these programs and service, pursuant to the intergovernmental agreement, the revenues are restricted to

support the operations of the aquatics facilities. Financing is provided from fees and charges for programs and activities.

1. The targeted restricted fund balance of the Family Aquatics Fund shall be calculated as follows:

- Restricted A portion of the fund balance may be restricted based on constraints imposed by creditors (use of bond proceeds, fund for repayment of bonds), grantors (use of grant funds), contributors (e.g., donors), or laws or regulations by other governments (e.g., compiled statutes).
- b. The remaining restricted fund balance for this fund will be targeted at a minimum level that is annually adopted by the Board of Trustees in order to provide for financial stability.

**Debt Service Fund** – This fund accounts for the accumulation of resources for and the payment of principal, interest and finance charges for bonded debt.

- a. Restricted A portion of fund balance may be derived from property taxes and therefore are legally restricted to the purpose of the fund.
- b. Assigned An accumulation in fund balance derived from interest income in the fund will be transferred to the General Fund on an annual basis.

**Capital Projects Funds** – These funds are established to account for and report financial resources that are restricted, committed, or assigned to expenditure for capital outlays including the acquisition or construction of capital facilities and other capital assets, excluding those types of capital related outflows financed by proprietary funds.

The Park District has multiple Capital Projects funds. These funds' fund balance will be considered restricted, committed, or assigned depending on the intended source/use of the funds.

## **Flow Assumptions**

Some projects (funds) are funded by a variety of resources, including both restricted and unrestricted (committed, assigned and unassigned). When restricted funds exist, those funds are used first, then unrestricted. For unrestricted funds, committed funds are used first, then assigned, then unassigned.

# Authority

a. Committed Fund Balance – A self-imposed constraint on spending the fund balance must be approved by ordinance or resolution of the Board of Trustees. Any modifications or removal of the self-imposed constraint must use the same action used to commit the fund balance and must be board adopted prior to the end of the fiscal year. Formal action to commit fund balance must occur before the end of the fiscal year. The dollar amount of the commitment can be determined after year end.

 Assigned Fund Balance – A self-imposed constraint on spending the fund balance based on the Park District's intent to use fund balance for a specific purpose. The authority may be delegated to the Executive Director and/or the Director of Finance & Administration.

An initiative identified in the District's 2015-16 budget is to renovate the men's locker room at the Eola Community Center. A total of \$200,000 is allocated for this construction. The proposed improvements are consistent with the renovation of the women's locker room, completed a couple of years ago. The scope of work generally includes replacing the existing lockers with new, larger wooden lockers, upgrading the shower fixtures, installing new toilet and shower partitions and new counter tops, installing a new ceiling with new tiles and LED lighting replacing the existing florescent lights, replacing the floor and wall tile, adding carpet squares, adding a new storage area, and painting.

The bid opening for the men's locker room renovation was conducted on March 3. The results of the bid opening are provided below:

Staff concludes that the bid submitted by Builders Land, Inc. is the lowest responsive, responsible bid following a review of their bid submission, a thorough scoping meeting with the owner and an extensive check of references, including the Forest Preserve District of DuPage County (Danada House renovation), DuPage Airport Authority (terminal building interior renovation), Geneva Park District (administration office restroom renovation), and the Village of Glencoe (public library renovation). While Builders Land will self-perform much of this work, they



will be subcontracting with two Aurora based firms- Cannonball Plumbing and Lewis Electric and Contracting.

I recommend to the Board of Trustees to approve the bid submitted by Builders Land, Inc. for the renovation of the men's locker room at the Eola Community Center in the amount of \$189,500.00.

An initiative of the District identified in FY 2016 is to overlay the Vaughan Athletic Center parking lot with a new asphalt surface. Funding is not provided until the new fiscal year starts on May 1, and the construction of this project is to coincide with the Vaughan Center operations schedule to minimize disruption to patrons. However, staff bid this project early in the calendar year to secure the best pricing. The low bid submitted by Abbey Paving Company, Inc. compares very favorably to the \$250,000 budget line item allocation.

The bid opening for the parking lot asphalt renovation work at the Vaughan Athletic Center was conducted on March 2. The results are as follows:

Because the cost of this work exceeds \$20,000, staff bid this painting. The scope of the work includes painting the concrete columns and steel I-beams in addition to the overhead wooden members.

The bid opening for the pergola painting work was conducted on March 2. The results are as follows:

South Broadway, the Fox Valley Park District's Police and Public Safety facility is facing growing obsolescence. According to the District's 2014 ADA Transition Plan, Theodia Gillespie the cost to remedy all of the ADA non-compliances is approximately \$599,000. Additionally, with limited garage capabilities, many of the District's vehicles are not **Denny Wiggins** under roof. Facing these challenges, while having additional opportunity for operational expansion at the Cole Center following the District's purchase of additional land at the rear of the site, staff has proposed to initiate the process of **Executive Team** relocating police and public safety operations to the Cole Center. The scope of this

relocation would consist of retrofitting a portion of the large operations storage area **Executive Director** and adjacent corridor into additional office space, and constructing a free standing **Diana Erickson** garage building to the north of the Cole Center building that would house up to Senior Director of twelve vehicles and ancillary storage. Finance & Administration

> Based on the District's successful existing relationship with Kluber, Inc. and their ability to produce pragmatic and budget-conscious, yet creative architectural and mechanical engineering solutions for the District, staff has asked Kluber to provide a proposal for design services related to the police and public safety relocation. This proposal is attached for review. Architectural fees for new construction typically range from approximately 8-1/2% to 10% or more of construction costs. Fees for remodeling design work are typically higher. The Kluber proposal is in the 10%-11% range based on our initial funding allocation of \$300,000 for FY 2016. Included in Kluber's scope is programming/interviews which are typically extra. The proposal also includes civil engineering (primarily to address storm water issues relating to the addition of garage/ impervious surface). Although the proposal also notes that construction services would be billed hourly as an extra, with the District's in-house capabilities, staff should not need much assistance with the bidding/construction administration.

I recommend to the Board of Trustees to approve the proposal submitted by Kluber, Inc. for architectural services for the police and public safety facility relocation in the lump sum amount of \$33,510.00.
