Outdoor Aquatic Financial Summary Narrative Period Ending July 31, 2017

The Outdoor Aquatic facilities opened in May 2017. Revenues for season passes are divided over the months of operation and divided evenly between facilities through closing in September. For the month of July, the allocated season pass revenue is \$117,841which is \$3,015 or 2.6% higher than last year at this time. The daily admissions for the month are \$336,718 which is flat to this same time year. Group admissions and program revenues are also unfavorable to last year by over 38.5% and program revenues are 23.4% unfavorable to last year at this time. The overall revenues from July are \$26,573 or 4.7% unfavorable from last year-to-date at the end of July.

Total expenses through July are \$1,279,464, which includes \$514,776 for capital enhancements and filter replacements at Phillips Park. Salaries and Wages are unfavorable to last year primarily due to switching the front desk responsibilities from Jeff Ellis to FVPD at both facilities, \$18,529 for water charges at Splash, \$6,169 for electric at Splash, \$5,034 for electric at Phillips Park, \$5,834 for maintenance and repairs at Phillips Park, \$7,731 for chemicals at Splash and \$5,618 at Phillips, and \$83,000 for contractual services from Jeff Ellis Management.

The consolidated financial income statement for both Splash and Phillips show an excess of expenditures over revenues by (\$737,740) less capital outlay for this is a net of (\$222,964) which is unfavorable to last year at this time of 53.1%.

Outdoor Aquatic Financial Summary Narrative Period Ending August 31, 2017

The Outdoor Aquatic facilities opened in May 2017. Revenues for season passes are divided over the months of operation and evenly divided between facilities through closing in September. For the month of August, the allocated season pass revenue is \$172,344 which is \$3,153 or 1.9% higher than last year at this time. The daily admissions for the month are \$409,332 which is \$17,726 less than last year at this time. Group admissions and program revenues are also unfavorable to last year by over 33.1% and program revenues are 21.6% unfavorable to last year at this time. The overall revenues from August are \$39,886 or 5.5% unfavorable from last year-to-date at the end of August.

Total expenses through August are \$1,509,126 which includes \$514,998 for capital enhancements and filter replacements at Phillips Park. Salaries and Wages are unfavorable by \$63,866 to last year primarily due to switching the front desk responsibilities from Jeff Ellis to FVPD at both facilities, \$8,427 for water charges at Phillips, \$6,959 for electric at Splash, \$6,030 for electric at Phillips Park, \$9,152 for maintenance and repairs at Phillips Park, \$16,968 for chemicals at Splash and \$5,546 at Phillips, and \$83,000 for contractual services from Jeff Ellis Management.

The consolidated financial income statement for both Splash and Phillips shows an excess of expenditures over revenues by (\$822,819) less capital outlay for this is a net of (\$307,821) which is unfavorable to last year at this time of 59.3%.

FY 2017 Accomplishments

- Successfully took over rentals, frontline staff and programming operations at both aquatic facilities from Jeff Ellis Management to help streamline operations and increase revenue.
- Acquired a Community Foundation Grant from the Robert William/Anita Nelson Memorial Endowment Fund for the third consecutive year to offer free swim lessons to 2nd graders.
- Improved the sound system at Splash Country Water Park by making necessary upgrades.
- Phase one improvement completed at Phillips Park Family Aquatic Center to include a climbing wall, additional water features, shade structures and concession area updates as well as the pump and filter room renovations.
- Several broken pipes and repairs were made at Splash Country throughout the season and erosion feeders were installed to complete the first phase of liquid to dry chemicals to improve economical efficiencies and safety.

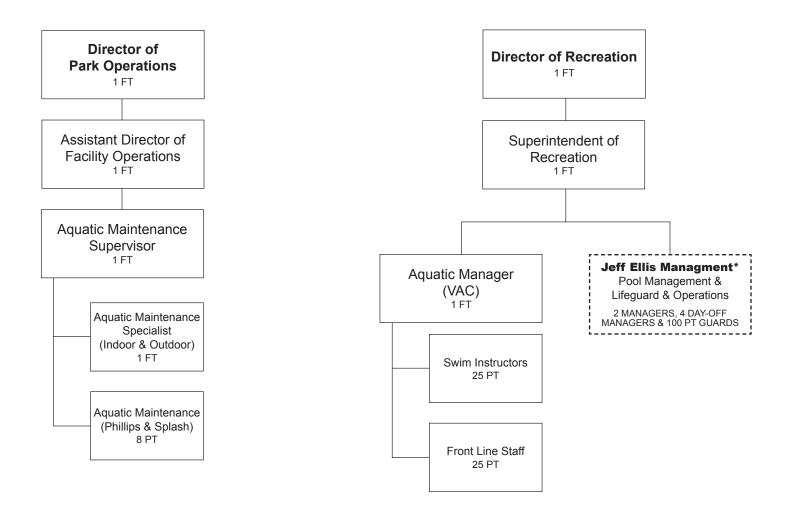
- Plans are underway to launch a new Recreational Swim Team at each of the three pools next summer where swimmers will compete in a city tournament during the summer season. The outdoor swim team will also provide patrons an additional opportunity to develop their skills past the advanced swimming lesson levels.
- Updating concessions tables and umbrellas at Splash Country Water Park.
- Improving and upgrading the sound system at Phillips Park Family Aquatic Center.
- Implementing mobile processing at our admission counters to increase processing speed and improve the customer experience.
- Boiler replacement at Splash Country.
- Slide repair and gel coating at both aquatics centers.

Future Year Objectives

- Host at least one CITY Swim Meet to showcase the Vaughan Center and to highlight our swim team.
- Redevelop the birthday party and group rental packages to provide additional add-on features such as lounge reservation, tents and programming activities.
- Continue to make improvements with the the swim lessons program to provide greater parent feedback, a permanent indoor rain location and alternating programming times between each facility to increase our participant to instructor ratios.
- Continue to collaborate with local schools and the Community Foundation to expand the 2nd Grade Learn to swim program to develop students swimming skills, improve water safety and awareness, and build physical and social skills, free of charge.
