8.1 Executive Director's Report

Director Pilmer reported on the following:

- The Commissioners received a list of District employees that volunteered for recent events in the District including National Night Out, Amazing Race, and BugFest.
- The Fiestas Patrias parade will take place in Aurora on September 15 at 10:30AM. FVPD PRIDE team will participate with a float and all Commissioners are invited to join the team.
- Director Pilmer and staff has recently met with Lisa McClellan, Executive Director of Wheatland Athletic Association regarding improvements at baseball fields used by WAA.
- Director Pilmer hopes to have more information regarding the District park to be located at the Coley Hospital site at the October board meeting.
- Director Pilmer asked Jeff Palmquist to give an update on the possible solutions to the stormwater issue at Golfview Park. Currently, the most feasible solution to increase the amount of water and time it takes to move stormwater to the release point is a two-phase plan that would begin with the construction of two 18" pipes and further improvements under the Gilman Trail. Partnering agencies have begun to pledge money to fund the solution.

9.0 PUBLIC COMMENT

Dave Gruhlke of Aurora, IL spoke about his concerns with the stormwater that affects his property near Golfview Park.

Fox Valley Park District Financial Statement Summary Narrative August 2019

Fund 100 - Corporate Fund

For the month of August, revenue received in this fund include \$556,938 in Property Taxes, \$20,943 in Rental Income which includes \$14,785 for park rentals, and \$14,068 in Investment Income.

Expenditures for the month include \$9,034 for IT consulting, \$19,553 for maintenance and repairs buildings, \$6,539 for paving repairs districtwide, \$5,652 for maintenance to equipment, \$11,870 for contractual mowing, \$7,691 for refuse removal, \$47,856 for contractual turf maintenance, \$14,245 for gasoline, \$7,552 for turf and landscape supplies, \$18,471 for equipment parts and supplies and \$45,106 in land improvements primarily for Weisner Park improvements and Waubonsie Lake tennis courts.

Fund 101 - Liability Fund

The Liability Fund provides for the payments of the comprehensive insurance coverage and overall risk management. Revenues for the month of August include \$55,035 and no significant expenditures were recorded for the month.

Fund 105 - Orchard Valley Golf Course

Since 2010, the Billy Casper Golf Management Company (BCG) took over the management of the Orchard Valley Golf Course and Restaurant. We will not be recording their monthly financial information on our financial system, except for the capital improvements and licenses agreement fees received and accrued along with other revenues as outlined in the agreement. No significant activity was recorded for the month of August.

Fund 107 – Aquatics

This fund is for the outdoor pools of Splash Country and Phillips Park which is under agreement for a 50/50 with the City of Aurora. Revenue for this fund includes \$151,027 for both parks fees and memberships are 2.9% favorable to last year-to-date through August and program revenues are unfavorable by 17.3% year-to-date from last year at this time.

Expenditures for the month include \$8,445 in natural gas at Splash Country, \$8,599 for electric at Splash Country and \$5,945 at Phillips, \$7,961 for water at Splash Country and \$17,586 at Phillips, \$10,000 for the aquatics study, \$13,600 for repairs at Splash Country, \$5,637 for alarm system at Splash and \$82,286 for Jeff Ellis & Assoc. lifeguarding services.

Fund 109 – Fox Bend Golf Course Proceeds

These funds are from the sale of Fox Bend Golf Course in 2006 and are to be used for appropriate golf related expenditures. No significant activity was recorded for the month of August.

Fund 200 - Recreation Fund

This fund includes all revenues and expenditures for the three facilities of Vaughan, Prisco and Eola in addition to Stuart Sports Complex and including administration areas such as Marketing, Parks, Executive and Administration. The Recreation fund is partially supported by property tax revenue and partially by user fees. Revenues for this fund include \$302,855 for Property Taxes, \$94,492 for Rental Income, \$9,234 in Investment Income, \$19,441 for merchandise sales, \$298,449 in Fees and Memberships and \$227,778 in program revenues.

Expenditures for the month of August include \$33,075 in electric at the VAC, \$7,654 at Prisco and \$14,614 at Eola, \$9,126 for water charges at the VAC and \$6,672 at Eola, \$9,034 for contractual IT services, \$44,671 for 2-months of contractual custodial services at Prisco, \$79,309 for 2-months of custodial services at Eola and \$18,129 at the VAC, \$5,573 for repairs at the VAC pool, \$6,016 for maintenance and repairs to vehicles, \$6,310 for irrigation services at Stuart Sports Complex, \$5,556 for IT licensing and support services, \$15,940 for credit card and bank services, \$13,550 for contracted turf and infield services, \$5,070 for furniture and fixtures at Eola, \$5,309 for fitness cleaning supplies at the VAC and \$6,743 for pool chemicals at the VAC.

Fund 201 - Museum Fund

This fund includes both Red Oak Nature Center and Blackberry Farm. Revenues for this fund include \$73,949 for Property Taxes, \$10,350 for Rental Income, \$2,434 for Investment Income, \$12,638 for gift shop sales at Blackberry Farm, \$125,023 for Fees and Membership, and \$59,415 for Program Revenues.

Expenditures for the month include \$7,333 for contracted custodial cleaning at Blackberry Farm, \$5,890 for maintenance and repairs to buildings at Red Oak Nature Center, \$20,204 for maintenance and repairs at Blackberry Farm, \$5,396 for the alarm system at Blackberry Farm and \$13,030 for repairs to the Blackberry Farm House.

Fund 202 - Police and Security Fund

For the month of August, revenues include \$62,688 for Property Taxes. Expenses for the month of August include \$6,118 for repairs to squad cars.

Fund 205 - Fox Valley Special Recreation

This fund is to provide recreational programs for the handicapped under a joint agreement. Revenues for the month of August include \$115,417 for Property Taxes. Expenditures include \$12,072 for inclusion fees and \$182,236 for ADA projects such as Stuart Sports Complex restrooms, Eola water fountain and playground fiber.

Fund 206 - Illinois Municipal Retirement Fund

For the month of August, revenues include \$62,688 for Property Taxes; expenditures included \$72,071 for payroll which is to cover all IMRF expenses.

Fund 207 - Social Security Fund

For the month of August, revenues include \$70,669 for Property Taxes; expenses included \$101,655 for payroll which is to cover all FICA expenses.

Fund 208 - Audit Fund

The Audit Fund accounts for all auditing services for District funds except for the Aquatics Fund which is shared with the City of Aurora and accounted for separately. No significant activity was recorded for the month of August.

Fund 301 - Land Cash Fund

The purpose of this fund is to legally track receipts of developer donation from the three municipalities per the Land Cash Ordinance. No significant activity was recorded for the month of August.

Fund 303 – Capital Development Fund

This fund has been created to use for capital equipment, capital needs in facilities and other capital development projects. Revenues for this fund include \$11,345 for Investment Income and \$18,599 for sale of capital assets. Expenditures for this month include \$56,720 for park improvements and \$16,363 for engineering services related to the Prairie Path project.

Fund 307 – 2017 Bond Fund

This fund tracks the bond proceeds from the 2017 General Obligation Bond issue and the associated capital projects for this issuance. Revenues for the month of August include \$5,267 for Investment Income and expenditures for the month include \$7,664 for replacement laptops.

Fund 308 – 2015A Bond Fund

This fund tracks the bond proceeds from the 2015 General Obligation Bond issue and the associated capital projects this issuance funds. Expenses include \$17,000 for Stuart Sports Complex North lighting project.

Fund 400 - Debt Service Fund

This fund is used to account for the accumulation of resources for and the payment of principal, interest and financing charges for the bonded debt. Revenues for this fund include \$484,887 for Property Taxes. No significant expenditures were recorded for this month.

Funds 600 - Employee Benefit Fund

The Employee Benefit Fund was the fund where all activity for the District's partially self-funded health plan is recorded for active employees. In 2019, the District is fully funded, and these funds will be used to pay run-offs and insurance premiums.

Funds 601 – Other Post Employment Benefit Fund (OPEB)

The OPEB Fund was the fund where all activity for the District's partially self-funded health plan is recorded for retirees. In 2019, the District is fully funded, and these funds will be used to pay run-offs and insurance premiums.

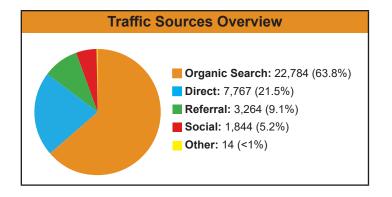

RE: Lease Agreement with Fox Valley Special Recreation Association

The District is requesting approval to the revised lease agreement between Fox Valley Special Recreation Association and Fox Valley Park District for use of Room 112 at Prisco Community Center. The original lease agreement commenced on October 1, 2016 and provided Fox Valley Special Recreation Association (FVSRA) exclusive use of Room 112 to offer special recreation services.

The revised lease agreement removes any verbiage regarding FVSRA's exclusive use of the space to allow the Park District the opportunity to provide programs and services during non-business hours, including evenings and weekends. Updates were also made to increase the monthly/annual rent payments, with one-year terms beginning January 1, 2020 that automatically renew with a 2% increase year over year.

I recommend to the Board of Commissioners to approve the revise lease agreement between Fox Valley Special Recreation Association and Fox Valley Park District for use of Room 112 at Prisco Community Center.

NON-EXCLUSIVE ROOM LICENSE AGREEMENT AND NON-EXCLUSIVE LICENSE FOR ANCILLARY USE OF CERTAIN AREAS ADJOINING THE PREMISES

Term of Lease/License: One-year initial term; annual renewals thereafter subject to

agreement of the Parties

\$19.63/sq.ft.; Year 5 \$20.02/sq.ft. Utilities shall be adjusted annually based on actual utility charges arising in the Center, prorated for the

square footage licensed hereunder.

Location of Licensed Premises: Room 112 of Prisco Community Center ("Center"), 150 W. Illinois

Avenue, Aurora, Illinois, subject to temporary relocation to

to functionally equivalent space within Center from time to time with reasonable advance notice, as may be necessary for Licensor's construction projects or other functions reserved by Licensor during

evening and weekend hours.

Purpose: Special Recreation and related uses, including office and

administrative purposes and parking.

LICENSEE: Fox Valley Special Recreation Association (FVSRA)

("Licensee") 2121 W. Indian Trail

Aurora, IL 60506,

being an association of public park districts and municipalities organized and operating under Sections 8-10a and 8-10b of the Park District Code (70 ILCS 1205/8-10a and -8-10b) and Sections 11-95-13 and 11-95-14 of the Illinois Municipal Code (65 ILCS 5/11-95-13 and -/11-95-14).

LICENSOR: Fox Valley Park District (FVPD)

("Licensor") 101 W. Illinois Avenue

Aurora, IL 60506,

being a Member Park District of FVSRA,

Licensee and Licensor being together referred to as the "Parties".

In consideration of the mutual covenants and agreements herein stated and on the terms and conditions herein set forth, FVPD hereby grants an exclusive license to FVSRA during daytime business hours, and FVSRA hereby licenses from FVPD solely for the above purposes and for the above Term and hours of use, the premises designated above (the "Premises"), and for the same purposes FVPD hereby grants to FVSRA and FVSRA hereby accepts a non-exclusive license for ancillary use of Center's washrooms and parking lot and, subject to availability and scheduling with Licensor's consent, of Center's kitchen, Community Room and Gym (the "Licensed Areas").

The Premises and Licensed Areas are depicted in the schematic drawing attached as <u>Exhibit A</u> to and made a part of this Exclusive Room License Agreement and Non-Exclusive License for Ancillary Use of Certain Areas Adjoining the Premises (the "Agreement").

RENT: SECURITY DEPOSIT: TERM.

FVSRA shall pay FVPD as rent for the Premises the sum stated above, monthly in advance of the first day of the respective month to which such rent payment relates, until termination of this Agreement. Rent for any partial month shall be prorated. Licensee shall return the premises at the end of the Term in the same condition as when delivered to Licensee, except for reasonable wear and tear and for intervening conditions attributable to any temporary reoccupancy of the Premises by Licensor to enable construction activities or other functions as permitted by this Agreement. The Term shall run from October 1, 2019 to September 30, 2020, and then shall automatically be extended from October 1 to September 30 of each subsequent year unless either Party gives notice to the other Party in writing at least sixty (60) days prior to the end of such Term that it does not wish to extend the Term for another year. If extended, the annual increase in the base rent shall be at the rate of 2 percent per annum, plus actual increased utilities incurred by the Center prorated for the area within the Premises.

2. WATER, GAS AND ELECTRIC CHARGES; CUSTODIAL SERVICES.

FVPD will pay all water, gas and electric light and power bills for and shall provide custodial services to the room occupied by Licensee during the Term of this Agreement. FVSRA shall be responsible for any internet, phone, cable communications service and devices or other media.

3. SUBLETTING.

The Premises shall not be sublet in whole or in part.

CONDITION ON POSSESSION.

FVSRA has examined and knows the condition of the Premises (Room 112) and has received the same in good order and repair, and acknowledges that no representations as to the condition and repair thereof, and no agreements or promises to decorate, alter, repair or improve the Premises, have been made by FVPD prior to or at the execution of this Agreement that are not herein expressed.

5. REPAIRS AND MAINTENANCE.

FVSRA shall keep the Premises and appurtenances thereto in a clean, sightly and healthy condition, and in good repair, all according to the statues and ordinances in such cases made and provided, and the directions of public officers thereunto duly authorized, all at its own expense, and shall yield the same back to FVPD upon the termination of this Agreement, whether such termination shall occur by expiration of the Term, or in any other manner whatsoever, in the same condition of cleanliness, repair and sightlines as at the date of the execution hereof, except for reasonable wear and tear and for intervening conditions attributable any temporary reoccupancy of the Premises by Licensor to enable construction activities or other functions permitted by this Agreement. Licensor shall be responsible for all major repairs, including but not limited to repairs of a structural nature of which involve building systems.

6. MAINTENANCE OF GROUNDS AND LICENSED AREAS; SNOW REMOVAL During the Term of the Agreement, FVPD shall maintain or provide and pay for maintenance of the Licensed Areas and the grounds on which the Premises are situated so as to keep them in safe and attractive condition. FVPD shall also provide snow removal as seasonally needed.

ACCESS TO PREMISES.

FVSRA will allow FVPD or any person authorized by FVPD reasonable access to the Premises for the purpose of examining or exhibiting the same, or making any repairs or alterations thereof which FVPD may see fit to make, so long as said repairs or alterations do not interfere with FVSRA's use of the Premises.

8. NON-LIABILITY OF LICENSOR (FVPD).

Except as provided by Illinois statute. FVPD shall not be liable to FVSRA for any injury done or occasioned by wind or by or from any defect of plumbing, electric wiring or of insulation thereof, gas pipes, water pipes or steam pipes, or from walks, or from the backing up of any sewer pipe or down-spout, or from the bursting, leaking or running of any tank, tub, washstand, water closet or water pipe, drain, or any other pipe or tank in, upon or about the Premises, nor for any such damage or injury occasioned by water, snow or ice being upon or coming through the roof, walks, or any other place upon or new to the Premises, or otherwise, nor for any such damage or injury done or occasioned by the falling of any fixture, plaster or stucco, nor for any damage or injury arising from any act, omission or negligence of other persons, or of FVPD's agents or FVPD itself, all claims for any such damage or injury being hereby expressly waived by FVSRA. Further, FVSRA waives any and all claims for liability against FVPD with respect to the use of the Center's parking lot by FVSRA and its employees, agents, guests and invitees and assumes all risk associated with vehicles that may be parked in the parking lot at any time or for any duration. The waivers and limitations contained in this Section 8 shall not apply to any liability incurred by FVSRA arising out of or occurring in connection with FVPD's negligence, reckless or intentional misconduct or for FVPD's breach of any provision of this Agreement. Nothing set forth herein shall constitute a waiver of either Party's rights and defenses available under the Illinois Local Governmental and Governmental Employees Tort Immunity Act, 745 ILCS 10/1-101 et sea.

9. INSURANCE.

FVSRA shall procure and maintain at all times during the Term, adequate insurance coverage with an insurer approved by FVPD and shall cause FVPD to be named as an additional insured thereon. The insurance coverage shall include commercial general liability ("CGL") insurance with coverages as set forth below and in an amount not less than Two Million Dollars (\$2,000,000.00) combined single limit per occurrence (subject to annual inflationary increases at the discretion of FVPD) for both bodily injury and property damage, with FVPD named as an additional insured thereon.

These coverages include, but are not limited to:

Premises/Operations
Products/Completed Operations
Independent Contractors
Contractual Liability
Liability assumed under an insured contract (including the tort liability of another assumed in a business contract.)

FVPD shall be included as an insured under the CGL, using Insurance Services Office ("ISO") additional insured endorsement CG 20 26 or a substitute providing equivalent coverage, and under the commercial umbrella, if any. This insurance shall apply as primary insurance with respect to any other insurance or self-insurance afforded to FVPD. Any insurance or self-insurance maintained by FVPD shall be excess of FVSRA's insurance and shall not contribute with it.

<u>Worker's Compensation Insurance</u>. FVSRA agrees that it and all of its subcontractors will comply with all applicable worker's compensation laws and will provide proof of worker's compensation and employer's liability insurance coverage. The commercial umbrella and/or employers liability limits shall not be less than \$1,000,000 each accident for bodily injury by accident or \$1,000,000 each employee for bodily injury by disease.

If FVPD has not been included as an insured under the CGL using ISO additional insured endorsement CG 20 26 under the Commercial General and Umbrella Liability Insurance required in this Agreement, FVSRA waives all rights against FVPD and its officers, employees, volunteers, and agents for recovery of damages arising out of or incident to FVSRA's use of the Premises and Licensed Areas hereunder.

Notification of Cancellation. All policies of insurance shall include a guarantee that thirty (30) days' advance notice shall be given by the insurer to FVPD prior to the cancellation of, change in, or non-renewal of such insurance and the same shall be endorsed on each policy and/or noted on each certificate provided to FVPD. If any of the insurance is cancelled, FVSRA shall on the date of termination cease operations on the Premises and Licensed Areas and shall not resume operations unless new insurance is in force.

10. RESTRICTIONS (SIGNS, ALTERATIONS, FIXTURES).

FVSRA shall not affix or exhibit or permit to be affixed or exhibited, any articles of permanent character or any sign with any writing thereon, to any window, floor, ceiling, door or wall in any place in or about the Premises, or upon any of the appurtenances thereto, without in each case first obtaining FVPD's written consent. Nor shall FVSRA commit or suffer any waste in or about said Premises or make changes or alterations in the Premises by erecting partitions or papering walls, or otherwise, without the consent in writing of FVPD. If FVSRA affixes additional locks or bolts on doors or windows, or places in the Premises lighting fixtures or any fixtures of any kinds, without first obtaining the consent of FVPD, such locks, bolts and fixtures shall remain for the benefit of FVPD, and without expense of removal or maintenance to FVPD. The provisions of this Section 10 shall not, however apply to FVSRA's equipment and moveable furniture.

11. HEAT.

FVPD shall furnish to FVSRA a reasonable amount of heat and air conditioning, as appropriate, whenever in FVPD's judgment necessary for comfortable use of the Premises, during customary business hours (excluding Sundays and holidays), but not earlier than 7:00 a.m. nor later than 9:00 p.m. unless otherwise specifically agreed by the Parties for particular events.

12. FIRE AND CASUALTY.

In case the Premises shall be rendered untenantable by fire, explosion or other casualty, FVPD may, at its option, terminate this Agreement or repair the Premises within sixty (60) days. If FVPD does not repair the Premises within said time, or the Premises shall have been wholly destroyed, the then-operative Term of this Agreement shall cease.

13. TAXES.

FVPD represents that the real property comprising the Premises and Licensed Areas has been determined by the Illinois Department of Revenue to be exempt from ad valorem property taxes. The Parties agree that the exempt status of the property should not be altered by their entering into this Agreement for lease of the Premises, given FVSRA's character as an association of public park districts and municipalities organized and operating under Sections 8-10a and 8-10b of the Park District Code (70 ILCS 1205/8-10a and -8-10b/) and Sections 11-95-13 and 11-95-14 of the Illinois Municipal Code (65 ILCS 5/11-95-13 and -/11-95-14), and FVSRA's use of the property for public special recreation purposes as Licensee pursuant to this Agreement. FVPD shall notify and provide the appropriate county assessment officer with a copy of this Agreement, as part of FVPD's next annual certification of exempt status of FVPD real property. FVSRA agrees to pay real property taxes, if any, attributable to the existence of FVSRA's lease of the Premises.

14. TERMINATION: HOLDING OVER.

At the termination of the Term of this Agreement, by lapse of time or otherwise, FVSRA will yield up immediate possession of the Premises to FVPD, in good condition and repair, except for ordinary wear and tear and for intervening conditions attributable to any temporary reoccupancy of the Premises by Licensor to enable construction activities or other functions permitted by this Agreement, and will return the keys to the Premises to FVPD at the place of payment of rent. If FVSRA retains possession of the Premises or any part thereof after the termination of the Term by lapse or time or otherwise, then FVPD may at its option within thirty (30) days after termination of the Term serve written notice upon FVSRA that such holding over constitutes either (a) creation of a month to month tenancy, upon the terms of this Lease except at double the monthly

rental specified in Section 1, or (b) creation of a tenancy at sufferance, at a rental of \$100.00 dollars per day for the time FVSRA remains in possession. FVSRA shall also pay to FVPD all damages sustained by FVPD resulting from retention of possession by FVSRA. The provisions of this Section 14 shall not constitute a waiver by FVPD of any right or re-entry as hereinafter set forth; nor shall receipt of any rent of any other act in apparent affirmance of tenancy operate as a waiver of the right to terminate this Agreement for a material uncured breach of any of the covenants herein.

15. LICENSOR'S REMEDIES.

If FVSRA shall vacate or abandon the Premises or permit the same to remain vacant or unoccupied for a period of ten (10) days, or in case of non-payment of the rent reserved hereby, or any part thereof, or in case of the material uncured of any other covenant contained in this Lease, then this Agreement and FVSRA's right to the possession of the Premises shall terminate if FVPD so elects with notice to FVSRA of such election and FVSRA agrees to surrender possession of the Premises as soon as practicable but in no event more than three (3) business days after receiving FVPD's notice that it has elected to terminate the Agreement.

16. COSTS AND FEES.

FVSRA shall pay upon demand all FVPD's costs, charges and expenses, including reasonable fees of attorneys, agents and others retained by FVPD, incurred in enforcing any of the obligations of FVSRA under this Agreement or in any litigation in which FVPD shall, without FVPD's fault, become involved through or on account of this Agreement. FVPD shall pay upon demand all FVSRA's costs, charges and expenses, including reasonable fees of attorneys, agents and others retained by FVSRA, incurred in enforcing any of the obligations of FVPD under this Agreement or in any litigation in which FVSRA shall, without FVSRA's fault, become involved through or on account of this Agreement.

17. REMOVAL OF LIENS.

In the event any lien upon FVPD's title results from any act or neglect of FVSRA, and FVSRA fails to remove said lien within ten (10) days after FVPD's notice to do so, FVPD may remove the lien by paying the full amount thereof or otherwise and without any investigation or contest of the validity thereof, and FVSRA shall pay FVPD upon request the amount paid out by FVPD in such behalf, including FVPD's costs, expenses and reasonable attorney's fees.

18. REMEDIES NOT EXCLUSIVE.

The obligation of FVSRA to pay the rent reserved hereby during the balance of the Term hereof, or during any extension hereof, shall not be deemed to be waived, released or terminated. FVPD may collect and receive any rent due from FVSRA, and payment or receipt thereof shall not waive or affect any such notice, demand, suit or judgment, or in any manner whatsoever waive, affect, change, modify or alter any rights or remedies which FVPD may have by virtue hereof.

19. NOTICES.

Notices may be served on either party, at their respective addresses given at the beginning of this Agreement, either (a) by delivering or causing to be delivered a written copy thereof, or (b) by sending a written copy thereof by United States certified or registered mail, postage prepaid, addressed to FVPD or FVSRA at said respective addresses, in which event the notice shall be deemed to have been served upon the earlier of actual receipt or the fifth business day after mailing.

Notices may also be served on either party (c) by facsimile transmittal by either party to its FAX number specified below, with confirmation of receipt, or (d) by electronic mail to either party at the email address specified below, with confirmation of receipt:

20. INDEMNIFICATION.

FVPD and FVSRA agree to indemnify and hold each other harmless against any and all liabilities, claims, damages, causes of action, costs, expenses and fees, including reasonable attorney's fees, that either party incurs arising from or occurring in connection with the other party's negligent acts or omissions, reckless or intentional misconduct, or breach of any provision of this Agreement.

21. MISCELLANEOUS.

- (a) Provisions typed on and all riders attached to this Agreement and signed by FVPD and FVSRA are hereby made a part of this Agreement.
- (b) FVSRA shall keep and observe such reasonable rules and regulations now or hereafter required by FVPD, which may be necessary for the proper and orderly care of the Premises and Licensed Areas.
- (c) All covenants, promises, representations and agreements herein contained shall be binding upon, apply and inure to the benefit of FVPD and FVSRA and their legal representatives, successors and assigns.
- (d) The rights and remedies hereby created are cumulative and the use of one remedy shall not be taken to exclude or waive the right to the use of another.

22. SEVERABILITY.

If any clause, phrase, provision or portion of this Agreement or the application thereof to any person or circumstance shall be invalid, or unenforceable under applicable law, such event shall not affect, impair or render invalid or unenforceable the remainder of this Agreement nor any other clause, phrase, provision or portion hereof, nor shall it affect the application of any clause, phrase, provision or portion hereof to other persons or circumstances.

23. AMENDMENT OF AGREEMENT

This Agreement may amended only by means of a writing which refers specifically to this Agreement, and is signed by a duly authorized representative of each of the Parties.

WITNESS, that the Parties hereto, by their duly authorized officers, have signed this Agreement, which shall be effective as of the date first stated above.

RE: Districtwide Electric Contract Approval

In February 2020, the District's current electric contract coordinated by Progressive Business Solutions will end. The District again utilized Progressive Business Solutions in Aurora to solicit proposals and act as the District's broker for this energy purchase bid.

Currently, the District's contract with Constellation NewEnergy is an "All Inclusive" fixed rate of \$0.06422/kWh that includes 100% Green Power for all facilities (37). Progressive Business Solutions received pricing from 11 retail electric providers; Constellation New Energy was the lowest responsible responsive bidder for an "Energy Only" 100% Green Power at \$0.03153 rate on all facilities.

By receiving "Energy Only" pricing options, the District will be able to capture future reductions in Capacity, Transmission, and Delivery Cost for current and future energy efficiency projects.

Securing the new contract through Constellation NewEnergy anticipates an annual supply cost reduction of \$37,646/yr.

I recommend the Board of Commissioners allow staff to enter into a 60-month contract for the purchase of 100% Green Electricity from Constellation New Energy in coordination with Progressive Business Solutions.

RE: Bulk De-Icing Salt Purchase

The District's FY 2019 budget accounts for the replenishment of bulk de-icing road salt for the City of Aurora. Fox Valley Park District utilizes the City of Aurora bulk de-icing salt storage facilities at the Broadway and Kautz locations to treat District sites. The District then replenishes the salt the following year by soliciting proposals for material and delivery.

The District utilized 250/tons of bulk de-icing salt during the 2018/19 winter season. This salt is different than the bagged product we use along sidewalks and entryways (1,1012 bags used during the 2018/19 season) as well as the liquids we pre-treat and pre-wet with (2,425 gallons used during the 2018/19 season). The District mobilized for 18 multi-day snow or ice events during the 2018/19 season.

To secure the most competitive pricing, staff solicits proposals for bulk road de-icing salt form local vendors. Prices were provided by two vendors this season indicated below:

I recommend to the Board of Commissioners to approve the purchase of bulk road de-icing salt in the amount of \$23,000 from National Seed.

RE: VAC Lobby Desk

The FY 2019 Budget included funding for the installation of an Entry Desk at the Vaughan Athletic Center. The Engineers Estimate of Probable Cost (EOPC) was \$23,572 for the associated millwork. On October 1, 2019, staff received two bids for the subject project well in excess of the EOPC. Considering this, staff recommends rejecting the bids. Staff will continue to review options to move the project forward at the budgeted funds.

RE: 1.0-Acre Park in Gramercy Square Subdivision Naming

At the June 17, 2019 meeting of the Fox Valley Park District Board of Commissioners, the Board approved the acceptance of the 1-acre park site in the Gramercy Square subdivision. Gramercy Square is the new townhouse development, constructed by MI Homes, south of 75th Street near Route 59. The developers have since completed their title transfer obligations and the park site is now owned by the Park District. Formal Board action of park naming subsequently occurs in conjunction with park site acceptance/District ownership.

The District's naming policy provides a list of criteria and considerations for the naming of parks. For ease of park identification, the first criterion suggests naming the park after the identifiable subdivision within which the park clearly lies. With this new park site wholly within the Gramercy Square subdivision, staff recommends that the naming criterion be followed, and the park be named Gramercy Square Park.

I recommend to the Board of Commissioners to approve the naming of the 1.0-acre park site located in the Gramercy Square subdivision as Gramercy Square Park.

RE: Eola Community Center Electronic Sign Board Upgrade

In the 2019 Budget, funds were identified for community center branding. The Eola electronic sign board is nearing the end of its useful life and requires replacement. The District views this replacement as technology and software specific. As such, a common procurement exemption is the purchase, delivery, movement, or installation of data processing equipment, software, or services. The District secured pricing from Correct Digital Displays from Sheridan, IL, which completed the Prisco electronic sign board replacement. They also provide service to other signs in the District at Blackberry Farm and Orchard Valley Golf Course. Correct Digital Displays submitted a price of \$26,849 for its replacement. Staff is requesting a not-to-exceed amount of \$30,000 to cover the proposal plus any unforeseen electrical improvements.

I recommend the Board of Commissioners approve the purchase and installation of the Eola Electronic Sign Board replacement in the not-to-exceed amount of \$30,000.

RE: Activity Guide Printing Extension

Per Board approved action from November 20, 2017, it is recommended that we exercise our one-year contract extension with LSC Communications for printing of our activity guide.

LSC Communications returned the lowest bid through RFP process in 2017, and the two-year contract represented an \$80,000 savings from the previous time the project was bid – this savings was primarily achieved through reduction of page count as more content goes online.

LSC Communications, formerly RR Donnelley, has a history of providing the District with outstanding services and quality.

I recommend to the Board of Commissioners to extend the optional 1-year contract for activity guide print services at an amount not to exceed \$160,000 for four issues, beginning with the Summer 2020 publication.

RE: Fox Valley Park District-City of Aurora Intergovernmental License Agreement

for Lake Street and Illinois Avenue Streetscape Improvements.

For some months, Fox Valley Park District staff have been working with City of Aurora staff to secure Aurora Tax Increment Financing (TIF) funding to assist the Park District in landscaping/streetscape improvements along Lake Street and Illinois Avenue at the Prisco Community Center. The Prisco Center lies within TIF District #5. One of the goals for the use of TIF #5 funding is Lake Street/corridor improvements. However, the City has minimal right-of-way along the Lake Street and Illinois Avenue sides of the Prisco Center. Therefore, by partnering with the City through the disbursement of TIF funding and allowing the Park District to take the lead in corridor beautification at the Prisco Center, the Park District and the City mutually benefit. The City is to contribute to the cost of landscape material; the Park District shall oversee the design, installation and be responsible for maintenance.

The mechanism that formalizes the conditions by which the City will provide a TIF funding contribution to the Fox Valley Park District is the attached Intergovernmental Agreement. As outlined, the City will contribute a payment of \$30,000. This contribution will go toward the Park District's purchase and installation of landscaping within the areas indicated on Exhibit A.

I recommend to the Board of Commissioners to approve the Intergovernmental License Agreement between the Fox Valley Park District and the City of Aurora for Lake Street and Illinois Avenue Streetscape Improvements.

WHEREAS, the City has a population of more than 25,000 persons, and is, therefore, a home rule unit under Article VII of the Illinois Constitution of 1970; and

WHEREAS, Article 7, Section 10 of the Constitution of the State of Illinois, 1970, authorize units of local government, including park districts and municipalities, to enter into agreements to exercise, combine or transfer power or functions not prohibited to them by law or ordinance; and

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 220/1 et seq.) authorizes units of local government to Illinois to exercise jointly with any other public agency within the State, including other units of local government, any power, privilege, or authority which may be exercised by a unit of local government individually and to enter into contracts for the performance of governmental services, activities and undertakings; and

WHEREAS, under Section 8-18 of the Illinois Park District Code, 70 ILCS 1205/8-18, the Park District has the power and authority to develop, operate, finance and participate in joint recreational programs with contiguous cities and to enter into joint agreements pertaining thereto, including the joint use of facilities and equipment; and

WHEREAS, the CITY and FVPD wish to express their mutual desire for intergovernmental cooperation for the benefit of its neighborhoods and surrounding community within the CITY and FVPD boundaries; and

WHEREAS, the CITY wishes to cooperate with the FVPD to provide a financial contribution to assist in the purchase and installation of new landscaping along Lake Street and Indian Trail as shown on the Location Map hereto as Exhibit A to expedite the City's vision for improved streetscaping and beatification along the Lake Street Corridor at a highly visible intersection where no City-owned right-of-way exists; and

NOW, THEREFORE, for the consideration of the mutual promises and undertakings set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. <u>Incorporation of Recitals</u>. The foregoing recitals to this Agreement are substantive and are hereby incorporated into the Agreement as though fully set forth herein.

- 2. <u>Monetary Contribution</u>. The City hereby agrees to assist FVPD in its purchase and installation of various landscaping materials as well as an irrigation system by contributing a one time payment of thirty thousand dollars (\$30,000.00) to the FVPD.
- 3. <u>Maintenance</u>. The FVPD agrees to mow, trim, and maintain the landscaping in good condition. Further the FVPD agrees to be responsible for any costs associated with maintenance and upkeep of the landscaping and irrigation sytem.
- 4. <u>Entire Agreement; Integration; Amendments</u>. This Agreement, along with any documents incorporated herein, constitute the full and complete understanding of the Parties as to the terms and conditions of the payment made by the City to the Park District. This Agreement supersedes any and all previous representations, understandings, and agreements, whether oral or written. This Agreement may not be modified except in writing, signed by both Parties.
- 5. <u>Severability</u>. This Agreement shall remain in full force and effect even if one or more of its terms or provisions have been held to be invalid or unenforceable. The term found invalid will be ineffective without invalidating the remaining provisions of this Agreement.
- 6. <u>Counterparts</u>. This Agreement may be signed in counterparts and each of the said counterparts shall be considered an original.

IN WITNESS WHEREOF, the Parties have set their hands and seals the day and year first written above and the signatories hereto represent that they are duly authorized to execute this Agreement on behalf of their respective bodies.

Agreement for Use of a Barn and a Portion of Surrounding Land at the West

Aurora Forest Preserve

The Kane County Forest Preserve District's West Aurora Forest Preserve is located along Hankes Road approximately ¾ mile to the northwest of Orchard Valley (see attached Location Exhibit and Exhibit A). A number of structures stand along the north side of Hankes Road, including a barn and adjacent shed. Through coordination between the Forest Preserve District and the Park District, the Forest Preserve District expressed a willingness to allow the Park District to utilize the barn and shed for storage. The FVPD Operations Department would use these structures as cold storage, particularly to house West Maintenance and Stuart Sports Complex equipment under-roof during the off season, as well as equipment from Blackberry Farm.

Park District staff is working with Attorney Hodge and Forest Preserve staff to draft the license agreement. The length of the agreement is to be 20-years. In exchange for the use of the barn and shed, the Park District shall agree to paint the barn and keep the structures and surrounding 1-acre area (175' x 248') well maintained for the duration of the agreement. The agreement in its final form should be completed and presented to the Board of Commissioners on October 19.

I recommend to the Board of Commissioners to approve the Intergovernmental License Agreement between the Forest Preserve District of Kane County and the Fox Valley Park District for the Park District use of a barn and a portion of surrounding land at the Aurora West Forest Preserve.
