TERMS:

- Additional guests are \$7/resident and \$9/non-resident, max capacity 25 people in the Party Room/ max capacity 30 people in Party Patio.
- All pool party attendees must have a completed waiver. Guests wearing life jackets must be within arm's reach of parent or guardian at all times.
- \$75 deposit due at time of booking, balance due 10 days prior to party.
- Refunds will be issued only if canceled 21 days in advance of party (less \$5 service charge).
 - 11-20 days in advance deposit is nonrefundable.
 - 10 days or fewer in advance full amount is due.

Aquatic Center Rules & Regulations

Fox Valley Park District is committed to ensuring the safety of guests, and asks every party attendee parent or guardian to follow these regulations:

- 1. Guests and participants entering the party room/party patio and/or pool deck are included in the guest count or must pay admission.**
- 2. Guests must be at least 48 inches tall to ride the slides.**
- 3. No helium balloons allowed**
- 4. Guests wearing life jackets must be within arm's reach of parent or guardian at all times.**
5. No decoration can be taped/secured on Park District signs (Party signs, emergency signs, etc)
6. Children under 12 years old are to be accompanied and actively supervised by a guest 16 years and older.
7. Parents or guardians are responsible for supervising their children. Lifeguards are on duty to enforce rules and respond in case of emergency.
8. Thank you for wearing commercially sold swimsuits to participate in recreational aquatic activities.
9. White T-shirts are allowed to be worn.
10. All life jackets must be U.S. Coast Guard approved. Limited number of life jackets available to use.
11. Guests are encouraged to make any special needs known to the management, who will be happy to assist guests.
12. Tobacco, alcohol and glass containers are strictly prohibited.
13. Cell phones may not be used in the locker rooms.
14. Thank you for ensuring that all apparel and footwear brought into the facility and worn on the deck are clean.
15. Children not yet toilet trained must wear a swim diaper.
16. Guests are required to shower before swimming.
17. Management reserves the right to close the facility due to unsafe conditions.
18. Admission into the facility may be refused to persons with potentially hazardous medical conditions.
19. Please lock belongings. The Fox Valley Park District is not responsible for loss or theft of any personal items.
20. Management may modify these regulations to ensure the safety of guests.
21. Vigilance Awareness Training is conducted. Testing provides the aquatic staff with training when safety mannequins are placed into the pool for practice rescues.
22. Decorations are allowed as long as they are secured with painters tape.
