

Warning of Risk and Waiver and Release of All Claims

In consideration of the granting of my request to participate in a certain canoe race to be held on the Fox River at or near Aurora, Illinois, on Saturday, June 1, 2024, sponsored by the Fox Valley Park District, I do hereby waive any claim for injury to my person or damage to my property that may arise out of any injury caused through any act of commission or omission of the Fox Valley Park District, its officers, employees or agents. As such participant, I undertake to assume the risk of all dangerous conditions in or about said canoe race and the premises used in connection therewith, and I waive notice of the existence of any such condition at any place or at any time. As a participant, I am aware that there is still a risk of serious injury and that the Fox Valley Park District cannot guarantee safety.

In further consideration of such permission to participate in said race, I hereby release the Fox Valley Park District, its officers, employees and agents from any claim which I may have of any nature whatsoever on account of any injury to my person or damage to my property which may be sustained or incurred in connection with, or arising out of my participation in said canoe race.

Important Race Information

- 1. Full entry fee for participating paddlers must accompany this entry form. Make checks payable to Fox Valley Park District. Waivers must be signed and included.
- 2. Team and/or classification changes by contestants must be notified to registrar on or before May 31.
- 3. Check heat sheets beginning Thursday, May 30 at 5 p.m., for start times at wherefunbegins.org. Pre-race packet pickup will be held 5 to 8 p.m. Thursday, May 30, and Friday, May 31, at Prisco Community Center, 150 W. Illinois Ave. in Aurora.
- 4. No refunds for canceled team.
- 5. If race is canceled by officials due to lightning or dangerous river conditions, entrants will receive a full refund.
- 6. Each participant must have PFD devices that are wearable–Coast Guard type I, II or III. Flat cushions are not acceptable. PFD must be worn by all non-swimmers and all participants under the age of 14.
- 7. An IDNR boat registration sticker is not required for this race.
